**INFORMATIVE ON THE PROTECTION OF PERSONAL DATA FOR PERSONS

In compliance with the provisions pursuant to and by effect of art. 13 Legislative Decree 30 June 2003, the company **Pharmanutra Spa, via the Lenze No. 216/B - (56122) Pisa (Italy)** - informs interested parties about the purposes and methods for processing personal data collected, their scope of communication and dissemination, in addition to the nature of their contribution.

PURPOSE

The personal data collected from interested parties, to be processed, are used directly to complete applications for subscription to the newsletter and mailing list that contains information and communications on products and promotions, with unwavering observance of the principles of lawfulness and fairness and in compliance with the provisions of the law.

METHOD OF PROCESSING

Data processing is carried out on hardcopy, computer and telematic supports by appointed internal parties. The data are stored in electronic archives and, residually, on paper with full insurance of the minimum-security measures provided by legislature.


COMMUNICATION AND DISCLOSURE

Personal data collected will not be distributed, sold or exchanged with third parties without explicit consent, with exception to the communications required to perform the activities stated in the purposes.

RIGHTS

You may enforce their rights as expressed by articles 7, 8, 9 and 10 of Italian Legislative Decree June 30, 2003 n. 196 by contacting the data controller. In particular, according to Art. 7 you have the right to obtain confirmation on the existence of personal data concerning you, even if not yet recorded, and their communication in intelligible form. You have the right to be informed on: a) the origin of personal data; b) the purposes and methods of processing; c) the logic applied in case of processing with the aid of electronic instruments; d) the identity of the owner, officer and representative appointed under article 5, paragraph 2; e) the parties or categories of parties to which the data may be communicated or who may gain access to data given their role of representatives appointed within State confines, officers or operators.

You have the right to: a) the updating, rectification or, when interested, integration of data; b) the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for

which the data were collected or subsequently processed; c) certification that the operations in points a) and b) have been reported, also as regards their content, to parties whose data were communicated or disclosed, except if this requirement is objectively impossible or in cases that clearly entail frivolous deployment of resources disproportionate to observance of the right protected. You have the right to object, in whole or in part: a) for legitimate reasons, the processing of personal data, pertinent for collection purposes; b) the processing of personal data for purposes of sending advertising materials or direct selling or for carrying out market research or sales communications.
